We are pleased to inform you of our robust sales performance on the auspicious occasion of **Akshaya Tritiya (19th April 2026)**, marking a strong start to Financial Year 2026-27.

Sustained Growth Momentum

Building on the previously reported strong operational milestones, regarding YoY growth in Gudhi Padwa sales (23rd March 2026) and **96.9% YoY** revenue growth in Q4 FY26 (6th April 2026), we are pleased to note that this momentum has continued into the new financial year.

Akshaya Tritiya Revenue Performance

The Company recorded a **Revenue of ₹127.27 Millions** on Akshaya Tritiya (19th April 2026) for F.Y. 2026-27, as compared to ₹34.63 Million recorded on the same occasion in F.Y. 2025-26 representing a **year-on-year growth of 2.67 times (267.49%)**.

New Store Contribution

We are also pleased to highlight that our two recently inaugurated Exclusive Brand Outlets (EBOs) celebrated their first Akshaya Tritiya since opening and delivered a strong performance:

- **EBO 1 – Wakad, Pune** (inaugurated 4th September 2025)

Together, these two outlets contributed a combined revenue of **₹6.87 Million**, reflecting encouraging consumer acceptance and brand traction in their respective micro-markets.

As on this date, the total store count is 36 stores (2 EBO's / COCO stores and 34 SIS stores).
